Purpose: At the meeting of the Business Support O&S Committee on 25

August 2016 Members requested a briefing note on the latest

position regarding Non Domestic Rating appeals.

Heading: **Non Domestic Rating Appeals**

Background

Business rates are calculated based on the rateable value of properties and ratepayers can appeal against the value shown in the valuation list which is produced by the Valuation Office Agency (VOA). If the appeal is granted the ratepayer can benefit from lower business rates from the effective date of the appeal.

Following a request from Members for an update regarding the latest position on non domestic rating appeals, an analysis of the number of appeals together with details of the funds set aside in the Council's accounts to make provision for successful appeals for the period 31 March 2014 to 31 July 2017 is set out below.

The Council uses a system called Analyse which is operated by Inform CPI and uses historical data trends, both locally and nationally to forecast possible reductions in rateable value arising from appeals held by the Valuation Officer. The forecast is for the reduction in gross terms as they do not know what exemptions or reliefs may be attributable to any given property. In Medway there is on average a 15% to 16% reduction in the gross rates after application of exemptions and reliefs and as such the Analyse provision is similarly adjusted. For the first two financial years, this reduced figure was used to make the appeals provision within the Council's accounts. At the end of 2015/16 the Analyse provision increased markedly, on the back of speculative apeals against the 2010 list and it was the Chief Finance Officer's opinion that this was unduly conservative. A lower provision (50% of the Analyse figure) was provided for. As at 31 July 2017, the Analyse provision has decreased to £12.880m compared to the figure in the Council's accounts of £12.092m essentially vindicating the position taken by Medway Council.
